INFORMATION

ALL VENDORS:

If you are selling packaged food items or offering product tastes, your business must have an Environmental Health permit valid in SLO County (call the county at 805-781-5544) and you must provide a Certificate of Insurance naming Paso Robles Main Street Association and the City of Paso Robles as additional insured entities on your policy of insurance.

**Jury selection:** Each vendor's work will be juried based on quality and originality. Please send two (2) photos of your work with application. Include a SASE with sufficient postage if you want photos returned. You will be notified by phone or mail of your acceptance. If you are denied participation in this event you will receive a full refund.

APPLICATION DEADLINE:

Applications must be in office by April 23, 2012, accompanied by a check, cash or money order payable to Paso Robles Main Street AND A SELF-ADDRESSED, STAMPED ENVELOPE.

LOCATION

Downtown Paso Robles City Park (12th and Spring Streets, Paso Robles, CA).

SET-UP TIME:

6:00 a.m. start if unloading from the street. **Vehicles are permitted in City Park to unload ONLY at assigned times.** Selling begins at 9 a.m. until 3 p.m. Space is forfeited if not occupied by 8:30 a.m. Spaces must be cleared, streets opened by 5 p.m.

CONFIRMATION/REFUNDS:

Confirmations are mailed two weeks before the event with space assignment and a map. Cancellations up to 7 days before event will be charged a \$15 handling fee. No REFUNDS WILL BE MADE After April 23, 2012. No rain checks; event goes forward rain or shine.

PARKING NOTICE:

VENDOR VEHICLES MUST BE REMOVED TO DESIGNATED PARKING LOTS (see map, over) — City Hall/Library lot or 12th & Railroad. **YOUR VEHICLE CANNOT BE PARKED IN OR AROUND THE PARK DURING THE EVENT.** This is a popular event and parking is tight; if customers cannot park, they will not come. **DO NOT DRIVE ON THE GRASS (UNLESS INSTRUCTED) AT ANY TIME.**

LIMITATIONS:

Food/drink vendors must be Main Street members and provide copy of health permit and insurance certificate naming Paso Robles Main Street and City of Paso Robles as additional insured.

Vendors PLEASE be responsible for cleanup and removal of merchandise AND TRASH after event. **Our volunteers should not have to clean up after you.** This protects the integrity of the event for all.

WHAT YOU NEED TO BRING:

Tables, tents, chairs, umbrellas, etc. Main Street will provide marked spaces and plastic bags for clean-up. Main Street will also be responsible for advertising the event.

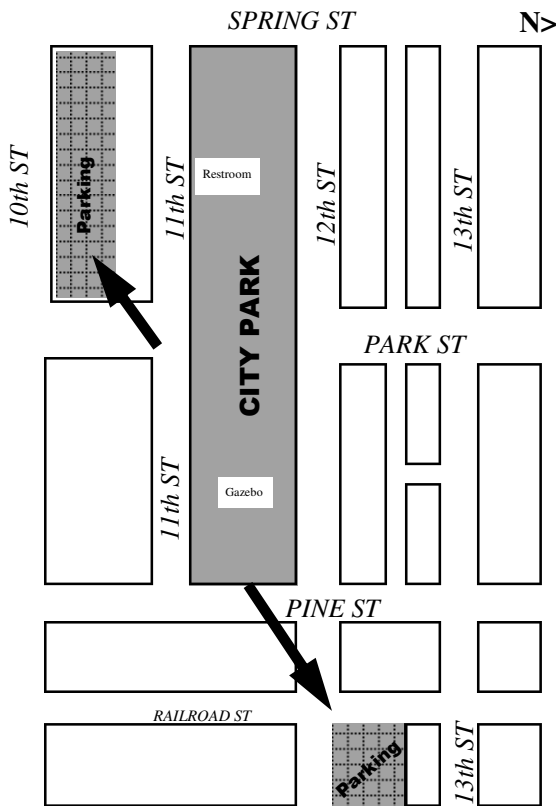
